



## Privacy Statement

Hunter Contracting Co. is committed to protecting your privacy and developing technology that gives you the most powerful and safe online experience. This Privacy Statement applies to the Hunter Contracting Co. website and governs data collection and usage. By using the Hunter Contracting Co. website, you consent to the data practices described in this statement.

### COLLECTION OF YOUR PERSONAL INFORMATION

Hunter Contracting Co. may collect personally identifiable information, such as your e-mail address, name, home or work address or telephone number. Hunter Contracting Co. may also collect anonymous demographic information, which is not unique to you, such as your ZIP code, age, gender, preferences, interests, and favorites.

There is also information about your computer hardware and software that is automatically collected by Hunter Contracting Co. This information can include: your IP address, browser type, domain names, access times and referring Web site addresses. ### USE OF YOUR PERSONAL INFORMATION

Hunter Contracting Co. collects and uses your personal information to operate the Hunter Contracting Co. website and deliver the services you have requested. Hunter Contracting Co. may also use your personally identifiable information to inform you of other products or services available from Hunter Contracting Co. and its affiliates. Hunter Contracting Co. may also contact you via surveys to conduct research about your opinion of current services or of potential new services that may be offered.

Hunter Contracting Co. does not sell, rent, or lease its customer lists to third parties. Hunter Contracting Co. may, from time to time, contact you on behalf of external business partners about a particular offering that may be of interest to you. In those cases, your unique personally identifiable information (e-mail, name, address, telephone number) is not transferred to the third party. In addition, Hunter Contracting Co. may share data with trusted partners to help us perform statistical analysis, send you email or postal mail, provide customer support, or arrange for deliveries. All such third parties are prohibited from using your personal information except to provide these services to Hunter Contracting Co., and they are required to maintain the confidentiality of your information.

Hunter Contracting Co. does not use or disclose sensitive personal information, such as race, religion, or political affiliations, without your explicit consent.

#### **USE OF COOKIES**

The Hunter Contracting Co. Web site use "cookies" to help you personalize your online experience. A cookie is a text file that is placed on your hard disk by a Web page server. Cookies cannot be used to run programs or deliver viruses to your computer. Cookies are uniquely assigned to you and can only be read by a web server in the domain that issued the cookie to you.

One of the primary purposes of cookies is to provide a convenience feature to save you time. The purpose of a cookie is to tell the Web server that you have returned to a specific page.
